Catoctin Mountain Park (cabin accommodation)

Cunningham Falls State Park (campsite with electricity, artist to provide their own tent or camping unit)

The purpose of the Artist in Residence program is to bring artists to Catoctin Mountain Park and Cunningham Falls State Park where they can be inspired by the surroundings and share their talents and vision with the park visitors (adults and children). The artists are expected to produce art that is appropriate for people of all ages and art that will encourage the audience to explore nature. We are looking for artists who can embrace the history and beauty of the parks and also attract diverse groups with their art and the programs they present to the public.

_____ I am prepared to “rough it” during the period of residency.

- At Catoctin Mountain Park a rustic cabin with water, sewer and heat are provided.
- At Cunningham Falls State Park a campsite with electricity provided.
 - Access to centralized bath house
 - Access to a water spigot on camping loop
 - Access to dump station at campground entrance/exit.
 - Camping units should not exceed 35’

_____ Artists are not allowed to sell anything on park property while in residency.

_____ In the Catoctin Mountain Park nothing can be picked up from the ground or plucked from plants. If you need plant materials for your art projects, contact AIR Program Chairman, Linda Sundergill (see contact information below). In Cunningham Falls State Park, if you need plant materials for art projects, please talk to a Ranger first.

_____ I am willing to donate by the end of my residency or within one year, a completed piece of artwork generated during my residency. Visual artwork must be framed and ready for hanging at time of donation. The artwork should not be larger than 36” by 48”.

_____ Donated artwork will become the property of Catoctin Forest Alliance, Inc. (CFA). CFA has the right to use the donated artwork for any purpose including sale of the original, and reproduction of the image for promotional or sales items. CFA can share this right with Catoctin Mountain Park and Cunningham Falls State Park.

_____ I am willing to teach or demonstrate to groups of art students and/or the public during my residency.

_____ I assume liability for personal injury or for the loss of articles during residency.
